F. MARVIN MYERS SERVICE AWARD

Mary Ann Vaughan, CCA

Elaine holds a bachelor of business administration degree in accountancy and information systems from the University of Texas of the Permian Basin. After graduating, she joined the staff of Peat, Marwick, Mitchell & Co. (now KPMG) and later joined the staff of Guinn, Smith & Co in Irving, Texas. After ten years with Guinn, Smith & Co., she started her own firm and later became a principal in the firm of Ratliff & Sommerville, P.C. She is currently the sole shareholder of the firm of Sommerville & Associates, P.C.

Elaine's practice is not only centered on nonprofit organizations in areas of tax compliance, but she also has a passion for training those who work for nonprofit organizations and who work with nonprofit organizations.
